We will be the personal guests of a Yeoman Warder (YW), who will be hosting us for the evening.

To comply with the rules and to maintain the charitable status of Historic Royal Places, this visit must be free for all members, but members will be expected to pay for any drinks in the Tower of London Club

Entry will commence no earlier than 7.30pm, at the West Gate entrance. No one, under any circumstances, can leave the Tower between 9.30pm and 10.05pm.

The club will close at 11.30pm and everyone must leave the Tower by no later than 11.45pm.

Subject to weather, the visit should include an hour-long guided tour within the grounds of the Tower. We will then be allowed to enter the club and later in the evening, maybe be allowed to watch the Ceremony of the Keys.

The minimum age for entry is 18 and those who are under 25 are asked to bring proof of their age.

Mobile phones must be turned off during the Ceremony of the Keys.

There is a strict dress code for the visit

Gentlemen:- Business suit, or a Blazer and trousers;
A collared shirt with a tie;
Appropriate shoes.

Ladies:- A dress; trouser suit; or blouse & skirt/trousers;
Appropriate shoes (high heels maybe difficult on the cobbles);

Outdoor coats maybe worn during the external tour.

But remember - NO JEANS (of any type) and NO TRAINERS
Non-compliance with the dress code will mean that you will not be allowed in the Tower of London
