The Trust also supports various charities associated with our industry and the City and makes a donation to the Lord Mayor's Appeal and the Mansion House Scholarship Scheme.

I am sure every Constructor would like the Company to build up a sizeable capital sum which, when invested, would provide additional annual income for more scholarships and awards and further assistance to the worthy charities already supported.

CHARITABLE TRUST FACTS

- The Constructors Charitable Trust has zero operating costs. All trustees and the Hon. Secretary provide their services free and pay their own expenses.
- Audit and Insurance Indemnity fees are paid by the Company.
- All income from investment dividends and members' donations except where specifically requested to be added to the capital sum, are annually used for scholarships or donated to various charities.
- The capital sum has increased by 49% over the last five years; this is thanks to fund-raising initiatives and individual donations.
- Currently fewer than 16% of members contribute regularly to the Trust. If all members donated £10 per month (eligible for Gift Aid) the Trust capital or annual donations would increase by more than £35,000 per year.

RECENT CAUSES SUPPORTED BY THE TRUST

Treloar's is a place where children and young people with severe physical disabilities come not only to gain an education, but also to develop their independence, confidence and skills to help them realise their potential, ensuring they get the best out of life.



Between them, the 250 students have more than 40 different disabilities, the most common being cerebral palsey, muscular dystrophy and spina bifida. More than 90 per cent of the students use a wheelchair to get around, 30 per cent have little or no speech and, most tragically, 20 per cent of them have life-limiting conditions.

However, at Treloar College and School, through a unique blend of education, medical care, therapy and independece training, we are committed to helping our students achieve everything they possibly can in a caring and supportive environment.

Barnardo's is a leading UK charity in the provision

of valued services to disadvantaged young people. The Hub Centre is based in a former synagogue and boxing hall in Stepney Green where 15-19-year-olds are trained for three days a week in plumbing, carpentry, painting and decorating and electrical trades before spending two days a week with supporting construction firms. Higgins Construction has already taken 14 placements, with six continuing with the company as apprentices.

SALISBURY CATHEDRAL DIRECT WORKS DEPARTMENT

There are 10 Stonemasons who are directly employed by the Cathedral in repairing and maintaining the fabric of the building, including at any one time one apprentice.

The Charitable Trust is assisting in the employment and training costs for the present apprentice Christian Sullivan (right) who is beginning his second of four years.

THE Charitable Trust was formed in October 1988 as the Company of Constructors – then known as the Company of Builders – sought to gain Livery status. A minimum capital sum of £100,000 was required before Livery status could be granted.

The Charitable Trust is administered by trustees who are all liverymen of the company. Its objectives are to advance education, training and

research in the construction industry, including building, civil engineering, architecture, surveying, engineering services, facilities management and procurement.

Advancement is achieved by awarding certificates, diplomas and other distinctions and by establishing scholarships, grants and awards to individuals. The Charity has the flexibility to

support any other charitable purposes that the trustees may decide.

Scholarships are ongoing and the trustees, in conjunction with the Charity and Education Committees, are working on expanding into other disciplines. Prizes and awards to educational bodies range from universities to craft colleges and the giving to appropriate City of London and construction industry charities is fully maintained.

To date, the Trust has been proud that it has no

overheads or costs. All costs are borne by the trustees or sponsors, so every pound raised by donations or investments is used to build up the capital sum of the Trust, which in turn increases the income to distribute or is distributed each year.

The trustees are aware that the majority of members would like the charity's capital sum to increase in line with some of the more-established

> and wealthy livery and to this end monies received from fund raising and personal donations, if the donor so wishes, can be directed to the capital sum. The Trust's main aim, however, is to distribute the majority of yearly income.

The trustees have been grateful for the continued fund-raising efforts by members of the company on behalf of the charity. A particular mention is required of

the charity lunch in the Long Room at Lord's Cricket Ground held in the summer of 2011, which raised in excess of £10,000. Well done to all those involved, particularly past master Martin Wade whose MCC connections oiled the wheels.

Although the trustees' main objective is to administer the Trust, they also wish to encourage all members of the company to donate where possible and support any fund-raising efforts. All causes are directly relevant to our industry.
